<sup>2</sup>For students who defend in the month of May in time to qualify for the June degree list, enrollment is extended through the date of Commencement in order to allow them to retain, through that date, certain enrollment privileges, including an active TigerCard, library privileges, and access to on-campus University Health Services. Additionally, enrolled students who complete the degree in the month of May in time to qualify for the June degree list may be allowed to stay in University housing through the end of June, depending on their individual contract, and may receive a June payment of student stipend support, depending on the source of that funding.
